On August 1, 2022, the Ohio EPA provided a revised letter of approval for the Revised Final Record of Decision for Atlas Scrap Yard. On August 23, 2022, the ARNG signed the ROD. On August 24, 2022, the Army provided a signed final copy to the Ohio EPA.

A final copy of the Five Year Review will be issued to all stakeholders in September 2022.

E. Indicate how much soil and groundwater was generated and/or transported and disposed as part of RVAAP restoration activities

Leidos has three (3) 55-gallon drums of liquid IDW staged at Building 1036 on secondary containment from the Spring FWGWMP sampling event. The drums are labeled "Pending Analysis". Inspections will be conducted weekly until the IDW is determined to be Nonhazardous at which time they will be conducted monthly while awaiting proper transport and disposal.

F. Describe activities planned for the following month (September 2022)

- The Environmental Support Services Contract with Chenega ended in April 2022. The Army will submit
 the contract for funding. This will impact the RTCs for the Draft Property Management Plan and REIMS
 and the public website are currently unavailable (as the management of these falls under this contract).
- 2. Leidos plans on responding to comments on the Draft Groundwater Well SAP letter, for the new wells to be installed to support the FS.
- 3. Leidos plans on resolving Ohio EPA comments on the Draft 2021 FWGW Draft Annual Report and submitting the report as final.
- 4. Leidos will submit the Final ROD (Version 2) for C Block Quarry to the Administrative Record File.
- 5. HGL will submit the Final Wetland Delineation Report to the Army.
- 6. HGL will submit the Preliminary Draft Remedial Action QAPP/Work Plan for the Group 8 MRS.
- 7. Arcadis will submit the RTCs to Ohio EPA's comments on the ODA2 UFP-QAPP.
- 8. DAWSON plans on preparing and submitting the Final 5-Year Review report.
