2021 RI/FS Completion Contract for IRP AOCs	N. Peters / Leidos	On August 24, 2022, the Army submitted RTCs for Ohio EPA comments on the Draft RI Report for Facility-wide Sewers. The Ohio EPA review of those RTCs is on-going. Leidos submitted the signed, Revised Final ROD for Atlas Scrap Yard to the CJAG Admin Records. Leidos also submitted the signed, Final (version 2.0) ROD for C-Block Quarry to the CJAG Admin Records.
Block D MRS and Group 8 MRS RD/RAs	Travis McCoun and Nicole Walworth / HGL	A revised draft Wetland delineation report was submitted to the Army on September 19, 2022 for review/backcheck and ultimate acceptance of the report. The Pre-Draft Block D MRS APP/SSHP was submitted to the Army on September 19, 2022.
RVAAP-004-R-01 ODA #2	Nicole Walworth & Steve Kvaal / Arcadis	Arcadis submitted the response to comments to the Ohio EPA on the Draft UFP-QAPP on September 14, 2022.
Compliance Restoration Sites	N. Peters / TBD	USACE and ARNG planned a new award for FY22 to continue restoration work at the compliance restoration sites. The new contract was not funded in FY22 but is expected to be awarded in early FY23. When the new contract is issued, these sites will be updated in the monthly status report.
2022 Environmental Program Support Services	N. Peters / Chenega	In a letter dated April 26, 2022, the Ohio EPA provided comments on the Draft Property Management Plan Appendices. Comment responses were delayed while waiting on the pending contract award. The new Environmental Program Support Services contract was awarded on September 29, 2022.
5-Year Review	Tanner Reliford / DAWSON	The Ohio EPA approved the Army's responses to their comments on August 26, 2022. A final copy of the Five Year Review will be issued to all stakeholders in October 2022 once the public notice affidavits are received.
RVAAP-66 Facility Wide Ground Water Monitoring	J. Trumble / Leidos	On September 20, 2022, the Army submitted responses to Ohio EPA comments on the Draft Monitoring Well Installation Plan. On September 21, 2022, the Army submitted the Final Annual FWGWMP Report. On September 27, 2022, Leidos began the Fall 2022 FWGWMP well sampling.
VEG Remediation Contract	N. Peters / Alaniz- Endpoint JV (AEJ)	The Draft Remedial Action Completion Report was submitted to the Ohio EPA on August 29, 2022. The Ohio EPA review of that report is on-going. This contract ended on September 26, 2022. Once Ohio EPA comments are received, the Army will discuss a path forward on how to address Ohio EPA comments and finalize the RACR report. Any locations that did not meet the cleanup goals will be addressed under a future contract.

E. Indicate how much soil and groundwater was generated and/or transported and disposed as part of RVAAP restoration activities

Leidos has three (3) 55-gallon drums of liquid IDW staged at Building 1036 on secondary containment from the Spring 2022 FWGWMP sampling event. The waste is Nonhazardous and labeled as such. Inspections are being conducted monthly while awaiting proper transport and disposal. The IDW report was finalized in September 2022 and proper transport and disposal is being coordinated.

F. Describe activities planned for the following month (October 2022)

- 1. The new Environmental Support Services Contract with Chenega was awarded on September 29, 2022. In October, this new contract will get started. Chenega will restore access to REIMS and the public website and begin preparing the RTCs for the Draft Property Management Plan.
- 2. Leidos plans on continuing, and completing the Fall FWGWMP well sampling, and conducting the Fall 2022 well gauging event.
- 3. Pending receipt of Ohio EPA concurrence with the RTCs, Leidos will finalize the RI Report for Facility-wide Sewers.
- 4. HGL will submit the Preliminary Draft Remedial Action QAPP/Work Plan for the Group 8 MRS
- 5. Arcadis will wait for approval of the RTCs on the ODA2 UFP-QAPP; pending acceptance of the RTCs, the Final ODA2 UFP-QAPP will be submitted.
- 6. Dawson plans on submitting the Final archive version of the 5-Year Review report.
