
SITE DESCRIPTION

- Rocket Ridge is a steep embankment along Sand Creek within Open Demolition Area #2 (ODA2).
- ODA2 was used for detonation of munitions for demilitarization purposes.
- Rocket Ridge slope was used for disposal of the demilitarized munitions at ODA2; although not all munitions appear to have been completely demilitarized.
- Rocket Ridge was used during late 1940's to early 1950's.

OBJECTIVES OF TCRA

- Remove all Munitions and Explosives of Concern (MEC) and Munitions Debris (MD).
- Remove all white phosphorus contaminated materials.
- Collect confirmation soil samples to verify removal.
- Restore the site.
- Prepare Removal Action Report (RAR) to describe in detail the actions taken to remove the MEC, MD and white phosphorus contamination at the site.





TCRA TASKS COMPLETED TO DATE

- MEC clearance within stream diversion work area – completed 11-18-10.
- Stream diversion completed 12-10-10.
- Excavation and removal of main dump area completed 2-3-11.

PROJECTED SCHEDULE FOR REMAINING TASKS

- Process excavated material through ferrous and nonferrous separator to remove munitions related items.
 Early April 2011.
- Remove, containerize and stage white phosphorus contaminated material. March - May 2011
- Confirmation sampling. May June 2011.
- Munitions and munitions debris survey of Sand Creek. May 2011.
- Site Restoration. June 2011.
